IEC 61508 CASS Templates

- What are Targets of Evaluation (TOEs)?
- CASS-508-FSM for Functional Safety Management.
- CASS-508-SLC for the Safety Lifecycle.
- CASS-508-SUB for the Subsystems and / or Elements.
- CASS-508-SYS for the Safety-related System.
- CASS-508-SW for any Full Variability Language (FVL) software.
- CASS-508-PLC for any PLC with Limited Variability Language (LVL) software.



IEC 62061 CASS Templates

- What are Targets of Evaluation (TOEs)?
- CASS-061 for FSM, hardware and lifecycle (some software)!
- CASS-508-PLC for any PLC with Limited Variability Language (LVL) software.



Why The CASS Templates Exist

- To support in the assessment of functional safety.
- Must be available before project start!
- To demonstrate compliance with IEC 61508 or related standard.
- Each functional safety standard has a lot of requirements (guide).
- Open to all and free-of-charge.
- Transparent methodology.
- Required by UKAS (accredited certification).

NOTE: Templates cover IEC, EN, and BS EN variants.



Rigor and Competence


- CASS templates reliant on the competence of the assessor!
- CASS templates can be used for any level of rigor.
 - Full FSA's.
 - Full assessments of functional safety.
 - Gap analysis of requirements.
 - Simple checklist of requirements (buying an asset).
- The rigor of any assessment must increase commensurate with the SIL.
- CASS templates must be used with a copy of the standard.
- CASS templates must be used by competent persons.
